

**The Data Exchange Incentive Program is now available to EMS Agencies in New York State**

The Statewide Health Information for New York (SHIN-NY) was developed by New York State to allow for the electronic exchange of clinical information and connect healthcare professionals statewide. Since its fruition, the SHIN-NY has enabled collaboration and coordination of care to improve patient outcomes, reduce unnecessary and avoidable tests and procedures, and lower costs.

The Data Exchange Incentive Program (DEIP) was established by the Department of Health (DOH), with support from Centers for Medicare & Medicaid Services (CMS), to help organizations across New York connect and contribute data to the SHIN-NY through a Qualified Entity (QE). EMS agencies can now connect to the SHIN-NY and offset their costs of connecting through the DEIP. The program consists of *two milestones for up to \$13,000* and to complete the program, organizations must contribute a pre-defined set of data elements. The deadlines for this program are:

**Milestone 1 (enrollment):** January 31<sup>st</sup>, 2021

**Milestone 2 (connecting and contributing a pre-defined data set):** August 31<sup>st</sup>, 2021
